They were captured on the early morning of the 2-11-80 in Curico, and might be in this moment in the "Regimiento de Curici" 22 km. south of Santiago- a place that does have a bad name as you certainly know.


As so many countries Chili too signed the international pact on Civil and Political Rights, that allows me to ask following questions:

- 1) I ask for information about the legal status of the prisoners I insist they will be set free immediately if there is no legal reason for prosecution.
- 2) I ask you very urgently to be human and decent in the treatment of your prisoners, in the name of humanity, christianity, even in the name of god, your family.....
- 3) I ask for the official declaration that Sergio Edward Martinez is your prisoner, I ask the reason why, and where he is at present.

I would be very grateful if you would be so kind to answer my questions, or took into consideration your power as a presidente and in the name of the intern. pact of civil and political Rights; (tode individuo tiene derecho a la libertad y al la seguridad personales) took guard of the lifes of your prisoners, in name once again, Sergio Edward Martinez, Patricio Gomez, Fransisco Marada Perez and the twelf others.

I ask you all this because I believe in a international, non-political non-violence movement, in human goodwill, and out of love for such a beautiful country, for Chili,




having learned that on the early morning of the 2-11-80 in Curico were captured and imprisoned the following persons;
